Minutes

1. Attendance, Quorum & Approval of the Agenda

The SOC Chair welcomes participants to the 78th System Operations Committee meeting which takes place in hybrid format (physical presence and teleconference). The Agenda is approved with the agreed changes.

The SOC Chair thanks the Regional Group Continental Europe for the successful approval of the permanent synchronisation of Ukrenergo to the CE grid taken during its meeting on 28 November 2023.

The SOC Chair and Vice Chair update the Committee on latest news from the General Assembly, Board, and Resource committee.

The SOC Chair presents for election a number of convenorship roles for different SOC structures, but as well the representation of SOC in the new Expert Group TSO – DSO at Board level.

TOP 1.3 Elections

SOC:

- Acknowledges the Chairperson decision to proceed by applause and decides on the following appointments:

 - Approves the nominee from TSCNET as Working Group Monitoring and Reporting convener for a two-year mandate starting 30 November 2023.
 - Approves the nominee from Terna and Red Eléctrica as Working Group European Innovative Dynamics and Protections conveners for a two-year mandate starting 30 November 2023.
 - Approves the nominee from PSE as Working Group Operational Framework Methodology for Evaluation convener for a two-year mandate starting 01 February 2024.
- Appoints the convener of the StG Strategy as the SOC representative in the Expert Group TSO DSO and mandates him to fulfil, on SOC behalf, all duties of the TSO-DSO Expert Group member as defined in the Terms of References of the Expert Group TSO-DSO.

2. Steering Group Resilient Operation

The Working Group Resilience of the Cyber-Physical Systems Convener presents to the SOC Members the outcome of the analysis into what can be the cyber risks of electric vehicle (EV) charging systems that can impact the business processes. The analysis is documented into a report that is proposed for approval.



The SOC Members receive updates related to ongoing activities such as, the draft cyber physical system risk assessment approach, the status of the Security Bulletin, the status on the Risk Preparedness Methodology update and the preparation of the regional electricity crisis scenarios, the ongoing cooperation with NGESO on HVDC ramping, the main changes proposed for updating the Incident Classification Scale (ICS) Methodology, the status of the Manually Controlled Load-Shedding project, and the ongoing ICS Scale 2 investigations.

3. Steering Group Operational Framework

The Steering Group Operational Framework Convener reminds the Members that the ENTSO-E and ACER framework agreement on data provision for Network Codes and Guidelines monitoring contains among others the list of data deliveries based on SO GL. This list was signed end of 2019 and the "interim data deliveries" started. The progress of RCC services implementation triggered an amendment and now the SOC Members are asked to approve the respective amendment for signature between ENTSO-E and ACER.

The Steering Group Operational Framework Convener informs about the activities that followed the approval of the amendments to the KORRR methodology in April 2022. These activities focused on the use of standards for data exchanges.

Following the SOC restructuration, the Working Group Probabilistic Risk Assessment (WG PRA) Terms of Reference was updated to reflect the new task on disturbance and fault statistics and is now being submitted for approval.

The Steering Group Operational Framework convener gives an update on the possible CGM methodology amendments. The Steering Group Operational Framework Convener informs that the PRA biennial report is under written approval and will be published in December 2023.

The Steering Group Operational Framework Convener gives an update on the Wind Eclipse project including the challenges and next steps.

The conveners then present to the members the preliminary outcomes of the TSOs-RCCs CGM process participation survey that was performed by ENTSO-E Secretariat in coordination with the CGM Operational Planning Data Environment Tasks Team (CGM OPDE TT).

The Steering Group Strategy Convener asks the Members to approve the updated Terms of Reference for the Steering Group Strategy and the Terms of References for the new Working Group on European Innovative Dynamics and Protections (WG EIDP).

9. Stakeholder engagement

The Steering Group Operational Framework Convener, with support from the SOC Chair, gives an overview of all the external stakeholders fora related to system operation, where ENTSO-E provides support in organisation of the meetings, but also technical expertise on different topics. In the case of the Electricity Coordination Group, ENTSO-E presented the updates to the Risk Preparedness Methodology and the Winter Outlook results.

10. Ukrenergo' s roadmap to access operational processes

The Work Stream Operational Processes Leader provides a status update on the actions developed since September 2023, highlighting the approved decisions taken by SOC, ICTC and LRG via written voting process at the beginning of October, regarding the implementation of a roadmap that will facilitate Ukrenergo to participate in selected operational processes.

11. Updates on 'modelling and simulation tools to handle new stability phenomena' project
