1. Welcome, practicalities
The chairs open the meeting by welcoming TSOs and NEMOs. The meeting agenda is approved, and the list of prealigned NEMO and TSO votes is established.

2. JOINT – General points
The minutes from the MCSC meetings on 01/09/2022, 22/09/2022 and 19/10/2022 were approved. The action point list was reviewed and the latest status shared with the MCSC.

# 3. JOINT - Important points to highlight & decisions requested

# 3.1) COM TF







Preparations for the 2nd MCCG meeting on 1 December have concluded. The meeting will be organized as virtual event using the GoToWebinar tool. The agenda was aligned with the market participants and published. The presentation was approved by MCSC. The MCCG ToR have been finalized by the MCCG co-conveners.

The COM TF prepared press releases on the successful SIDC 4th wave go-live and the successful conduct of the 2nd MCCG meeting. The slides for the MESC meeting on 7 December were drafted by the relevant WG/TFs.

## 3.2) Further improvements to joint governance

NEMOs and TSOs aim to remove unnecessary layers and/or smoothen their interactions to improve efficiency and effectiveness of work in the SDAC (and to some extent also in the SIDC) governance. A list of inefficiencies was compiled and a table of topics that define what will be in and out of scope for the MCSC organisation was prepared. The ad-hoc governance group now focusses on drafting a note to make the solution for the first set of improvements concrete and clear. Despite its complexity, good progress has been made in the description of the solution. Objective is to request at January's MCSC approval for the implementation of the first set of improvements.

### 3.3) Harmonisation of MCSC session file input material

Regarding how MCSC session file material is prepared and presented, there are historically different approaches for SDAC and SIDC in place. The Co-chairs have triggered a discussion in the joint ICT on how to harmonise the approach for the MCSC session file.

Based on the discussion in the joint ICT, 2 options have been identified. Option 1, in essence, extends the session file approach currently taken for MCSC as well as SDAC to SIDC. Option 2, in essence, ensures continuation of the current MCSC/SDAC as well as SIDC session file processes.

For both options, it is proposed to agree that draft session files are made available to MCSC members (in line with current SDAC timing) in order to get awareness of the topics for decision and prepare the relevant position.

#### 3.4) Legal TF

The content of the draft CIP agreement with Unicorn is finalized at Legal TF level and subject to a final sanity check.

The Legal TF is working on the fourth IDOA amendment for IDA operations. A first draft was prepared based on the original guidance of the IDA SG and alignment between the Legal TF and the IDA SG are ongoing.

Answers to legal questions in connection with IDA go live (legal compatibility of several go-live options) are being prepared.

The co-conveners of this newly established TF briefly introduce themselves. The initial tasks of the GOV TF will be the amendment of the Algorithm Methodology to include co-optimisation and the continuation of the work on joint TSO and NEMO governance improvements. The ad-hoc working group on governance will be dissolved soon and open deliverables will be handed over to the GOV TF.

### 4. JOINT - Any other business

# 4.1) Key take-aways 29/11 strategy meeting

The key take aways from the strategy WS are presented.

# 5. SIDC - Important points to highlight & decisions requested

# 5.1) Integrated plan

The QARM convener presented the plan for next 3 month. He informed that the 4th wave go-live went very smoothly, and the launch was successful. The R4.0. launch is planned on 2<sup>nd</sup> December is expected to go according to the plan.

### 5.2) SIDC OPSCOM Status Report

The OPSCOM convener presented the recent development in the SIDC operations. The downtimes since the last MCSC were only planned downtimes and currently we expect that the SIDC operational downtimes in 2022 will be 20% lower than in 2021.

# 5.3) SIDC QARM Status Report including IDA Topics

Due to the time constraints the QARM convener concentrated in presented the suggested decisions. All of them were agreed by NEMOs as well as TSOs with the exception of the contract for CIP IDAs. The final version is to be approved by deemed acceptance 1 week after the provision to MCSC.

# 5.4) SIDC MSD Status Report including IDA Topics

The MSD Convener concentrated on presenting the options concerning the IDA partial decoupling. The MCSC parties agreed to start with configurable decoupling of virtual broker. Other options are to be further evaluated.

## 5.5) SIDC BMSG Status Report

The BMSG Convener presented the suggested decisions. All of them were agreed by the NEMOs as well as TSOs.

#### 5.6) MCSC members questions to reports

No questions were raised to the reports.







# 6. SIDC – Any other business

The MCSC thanked the MCSC members, conveners and chairs for the work done for the project and wished success for the future endeavours.

# 7. PMO procurement, handover & SIDC resettlement transition

Due to the confidential nature of the topics discussed, no summary is published.

# 8. SDAC - Important points to highlight & decisions requested 8.1) SDAC OPSCOM

Since the last MCSC only a few operational incidents with lower severity occurred. Some RfCs went live like the increase in C01 blocks in EPEX trading hubs, the PMB11.3 technological updates, Euphemia 10.6\_fix4 and the removal of peak loads reserve in Sweden and Finland. Upcoming go-lives are the introduction of 2nd auction in the Baltics and Croatia, and the release of new PMB and Euphemia versions.

The work on allocating more time to the algorithm calculation within the daily operational processes to facilitate the 15 min MTU implementation started.

A decoupling training involving market participants was held in October.

#### 8.2) SDAC MSD

Although Euphemia is functionally ready for the 15 min MTU, the performance gap is still not closed for a successful golive. It is to be seen if the current simulations running until the end of 2022 will bring better results. In parallel the extension of the operational timings is being investigated.

Non-uniform pricing (NUP): Side payments financing options and NUP prototype update were done in the first part of the 4th study which was completed end of September. The second part of the study will focus on gaming strategies and simulations through Phyton framework and will be completed end 2022.

2030 future of the algorithm exercise - offshore wind study: Objective is to perform a mini market assessment combined with algorithm impact. Alignments with NRAs/ACER after the Future of the algorithm workshop in June continued and it was agreed to use the NTC approach as starting point for capacity calculation. SDAC MSD agreed on the topology of the study, scenarios, data preparation assumptions and initiated the study with N-Side. Results are expected by end 2022.

NEMOs and TSOs who have not yet provided a member for this newly established working group are reminded to do so by 7 December. The kick-off meeting will take place in January focusing on the TF scope and deliverables.

# 8.4) SDAC SF TF

Since June 2022 the Simulation Facility (SF) is out of operations, following a planned upgrade. Until today the IT provider was unable to restore the tool neither in the expected upgraded version nor by rolling back to the previous one. Latest information is that the SF will be operational mid-December again.

### 8.5) MCSC members questions to TF/project reports

No questions are raised.

# 9. SDAC - Any other business

#### 9.1) Letter from AST & Litgrid re. non-intuitive flows on LitPol Link

The topic of non-intuitive flows from Lithuania to Poland is raised and the next steps to investigate these are agreed.

# 10. Closure meeting

#### 10.1) Next meetings

The MCSC meeting schedule for 2023 is presented.
